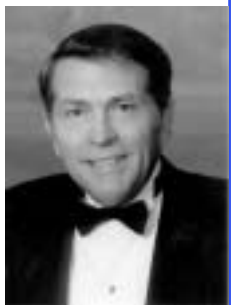
The Smile Maxilla: Advancing Esthetic Diagnosis and Treatment Planning

Featured Speaker: Dr. Stuart Isler

Dr. Stuart Isler received his DMD degree from the University of Pennsylvania School of Dental Medicine. He maintains restorative dental practices in New York City and Denville, New Jersey. He is past editor-in-chief of the Journal of Esthetic Dentistry and a member of the board of directors of the American Academy of Esthetic Dentistry.

He created the extramural department of Continuing Education at the University of Pennsylvania School of Dental Medicine and continues to administer his own 400 member study club, the Hospital Association of Neighborhood Dentists, for 28 years. He has been a consultant to various dental websites and is presently editor-in-chief of dentalVote.com, a ratings site for dental products and opinions. Dr. Isler has lectured both nationally and internationally on various topics in Esthetic Dentistry.

This presentation emphasizes the relationship between esthetic dentistry and beauty. Restorative dentists, working in partnership with periodontists, orthodontists, and laboratory technologists, have the ability to create more attractive patients. This can be realized by creating illusions to the bone that houses the maxillary teeth via changing the perception of the position and prominence of the arch form. We consider this bone the "smile maxilla", the sine qua non of facial harmony.



Highlights from the NJDA Board of Trustees Meeting, February 27, 2002

PRESIDENT'S REPORT: The Board reviewed the DDS report as informational, and approved a \$250.00 contribution to the ASDA NJDS chapter for its Lobby Day in Washington.

REPORT OF TASK FORCES

Task Force on Administrative Structure: DrFeinberg reported on the recommendations of the task force on administrative structure. Those recommendations were approved as follows:

- Establish a Personnel Committee whose duties will include periodic review of the employee manual, development of the details concerning a phased-in employee contribution for health benefits, and the exploration of alternative benefit packages.
- Compile and evaluate data on the next three Annual Sessions to determine if the convention should continue to be held mid-week at a casino hotel vs. a weekend meeting and, in 2004, reopen discussions with Pennsylvania regarding a regional meeting. The scheduling of scientific programs should be coordinated between the Councils on Annual Session and Dental Education, either through joint council activity or common NJDA staffing.

Task Force on Governance: DrRiva presented the interim report of the Task Force on Governance, and explained the group's information-gathering role in developing the preliminary recommendations for the Board's consideration. DrRiva also explained that the opinion of the task force to leave unchanged the structure of the individual components and number of trustees (recommendation 1) was not unanimous. Although some components reportedly have a difficult time recruiting volunteers for officer positions, no component representative approached the task force to request consideration of component reorganization, and that is largely the reason the task force recommended no changes be made.

The Board then discussed at length the remaining nine preliminary recommendations (one of which was added to review the duties of the Secretary, the others dealing with consolidations of various councils and committees). DrRiva requested that the Trustees consider this report as informational, but to seek input from their components and be prepared to take action at the April Board of Trustees meeting. It was noted that changes to Councils would require a Bylaws revision.

The Board did approve a separate resolution for transmittal to the House of Delegates that would reduce from 71 to 50 the number of Delegates required for a quorum.

Task Force on Information Technology: DrCarotenuto presented the report on Information Technology that contained several suggestions for improvements to and greater utilization of technology. These include re-designing NJDA's website, continuing education for staff on features of the current Microsoft software, and taking full advantage of e-mail capabilities. For example, the entire Board packet could be sent electronically (including outside documents) if scanners were utilized. The task force did not feel teleconferencing was viable at the current time. The Board approved the task force suggestions to be implemented as appropriate.

Task Force on Fluoridation & Dental Wastewater: Dr. Graham presented the report, which included one resolution, approved by the Board, with regard to submitting a petition for rulemaking on behalf of the Oral Health Coalition to fluoridate New Jersey's drinking water. With regard to dental office wastewater, especially as it relates to mercury, the Task Force recommendation was to continue to carefully monitor the recommendations of the New Jersey DEP Mercury Task Force and, if and when appropriate, rely on ADA to provide the necessary scientific data to ameliorate any potential impact on NJDA members.

NEW JERSEY DENTAL SCHOOL REPORT: DrFeldman updated the Board on state budget cuts and how they will impact on NJDS, gave a demonstration on the NJDS e-curriculum (which includes over 100 textbooks on DVD to be used with laptops), and gave a PowerPoint presentation on the school's capital improvement program.
