Featured Speaker: Dr. Donald Lewis



Dr. Donald Lewis is a Diplomat of the American Board of Oral and Maxillofacial Surgery and is currently in private practice in Cleveland, Ohio. Dr. Lewis is an Associate Professor of Oral and Maxillofacial Surgery at Case Western Reserve University School of Dentistry and is a guest lecturer in the Department of Sociology at Kent State University as well as for the MBA program at the Weatherhead School of Business at Case Western Reserve University. He is also the Oral Surgery Consultant for the Cleveland Clinic. Dr. Lewis earned the designation of “Certified Fraud Examiner” from the Board of Regents of the Association of Certified Fraud Examiners. Dr. Lewis is one of only two dentists in the world to hold this designation. Through his efforts, Dr. Lewis has documented that health care professionals are uncovering white-collar crime in their practices. Dr. Lewis has also published numerous articles about white-collar crime in local, state, and national publications.

His mission was to raise funds and awareness of a very rare disease called, Fibrousdysplasis Ossifacans Progressiva. (MCDS has made a donation to combat the disease in lieu of honorarium). This presentation was combined with a scientific program about the "Florida Probe". In addition, we held the "Annual OSHA Certification Seminar" Thursday, June 16, 2005 from 6:30-8:30PM at St. Peter's Medical Center. ## NJDA Noteworthy News

STATE BOARD OF DENTISTRY REPORT – Dr. Robert A. Hersh

Enteral Sedation Regulation was adopted. Because of inadequate course availability, the permit requirement of this regulation will be deferred until July 1, 2006.

The Criminal Background check will not be implemented for dentists until the November 2007 biennial license registration renewal.

An amendment to the parenteral sedation and general anesthesia regulations has been drafted. This amendment will allow contract anesthesiologists without a hospital affiliation to provide anesthesia in dental offices.

The State Board is investigating whether records of minor infractions can be expunged. The current regulation contains no provision for the removal of minor infractions from the records of dentists.

A letter was read from UMDNJ regarding an Australian orthodontist who could not serve on the faculty of the dental school because of his non-licensed status in New Jersey. The issue of whether a dentist not licensed in NJ could participate in a “hands on” CE course in New Jersey was discussed. The issue was referred to committee for a more thorough evaluation.

Dr. Herbert Dolinsky has been elected to the position of President of the State Board of Dentistry and Dr. Peter DeSciscio has been elected Vice President of the State Board of Dentistry. Both are members of NJDA.

COUNCIL ON DENTAL EDUCATION & MEMBERSHIP – Ms. Tricia DeCotiis

Weekend Study Club continuing education courses have been arranged for the year. The first course will be held September 17th on Forensic Dentistry and to date has 17 registrants. The second course will be held October 16th on Digital Photography and has 19 registrants to date. The third course is scheduled for November 13th on The Risks, Benefits, Indications and Techniques for Immediate Loading/Provisionalization of Dental Implants and to date has 11 registrants. The 4th course is scheduled for December 10th and has 3 registrants to date. The subject is Beyond Pregnancy: Bringing a New Focus to Oral Health Issues of Women.

The Council on Dental Ed is also running the Dental Assistant scholarship program. September 15th is the deadline for students to submit applications. Four \$500.00 scholarships will be awarded by the Council.

The Employment Exchange Program is very active. To date we have 292 dentists, 76 dental hygienists and 24 dental assistants registered with the program.

As of the date of this meeting, 4,534 members have paid their 2005 dues.

The next Women’s Initiative course is scheduled for November 19th on the Fundamentals of Creating a Staff Driven Practice. This course will be available to members and non-members and their staffs. It will be held at the Pines Manor and will be funded by the company presenting the program, Staff Driven Practices.

COUNCIL ON DENTAL BENEFITS PROGRAMS – Ms. Mary Moskal

There was a meeting with representatives of the NJSOM to discuss problems that oral surgeons have relative to treatment that is covered under both a medical and dental plan, so that NJDA would be in a better position to assist. Many of the problems discussed were Delta-specific, and NJDA was able to communicate with Delta in advance in an attempt to gather information and solicit Delta’s assistance with its policy on submitting to the medical plan first. Significantly, Delta has agreed to assist dental offices in tracing medical claims to which the carrier has not responded. However, in a departure from past policy, Delta will be requiring dentists to submit EOBs from medical plans, even when the dentist knows that the procedure is not covered by medical. On another front, Delta Dental Plan is introducing a new plan (“Patient Direct”) that will be marketed to individuals without group dental coverage. This plan appears to be similar to the other discount programs already on the market. Finally, ADA has just posted on its website a “Third Party Complaint Form” similar to what NJDA has been doing for many years. Dentists who submit complaints via this mechanism will not receive assistance; it is for data collection purposes only.

There was a meeting with Congressman Pallone where it was vowed to bring together the resources to create more clinics in NJ to serve disadvantaged children. Governor Cody has created a \$30 million initiative to get ten more care facilities. These facilities (FQHC) are Federally Qualified Health Centers. Liberty Science is developing a program with the schools for oral health education and has contacted NJDA to be a partner. Mr. Meisel reported that the Task Force on Access to Care had one meeting with the New Jersey Department of Health & Senior Services. Future meetings are expected to involve the Department of Education and the Department of Human Services.

MARKETING & GOVERNMENTAL AFFAIRS – Mr. Eric Elmore

The membership directory is now on line at the NJDA Website. Any changes will be posted every six weeks, starting from July 31, 2005. Also, the internet message boards are now active.

Lastly, NJDA’s Give Kids A Smile (GKAS) is scheduled for Friday, February 3, 2006. We have joined with the ADA and will have the GKAS Day on the same day it is celebrated nationally.

COUNCIL ON GOVERNMENTAL AFFAIRS – Mr. Jim Schulz

The fluoride issue is being delayed and probably stopped because the Public Health Council is being changed to an advisory committee and they are not going to move the regulation at this time. Governor Codey has received a lot of correspondence

from other public health services indicating their disapproval of his action. Next week we will be meeting with Commissioner Jacobs of the New Jersey Department of Health and Senior Services.

On September 21, 2005 NJDPAC is having a fund raiser for Dr. Jeff Van Drew at the Association headquarters after the regularly scheduled Board of Trustees meeting.

NJDPAC is doing well and he thanked everyone for their support.

### COUNCIL ON ANNUAL SESSION

Annual Convention shows a \$50,000 surplus with a small amount owed still outstanding. As you know, the Society of Periodontists partnered with NJDA at the annual convention for the first time this year. The Taj Mahal will host the 2006 Annual Session and the speaker roster is well underway and should be finalized in September.

At the last Council on Annual Session meeting a resolution was passed which would require amending the NJDA Bylaws. The hygienists and assistants, who were co-sponsors of the Annual Session Convention and fully participated in all the Council's meetings, could not vote for the Vice Chair of the Council. The NJDA Bylaws state that only members can vote. Under the Bylaws, they can be consultants. A motion was made and adopted to amend the NJDA Bylaws to allow those participating organizations one vote per organization on all matters that come before the Council on Annual Session, including the election of the Vice Chairman

### EXECUTIVE DIRECTOR AND LEGAL COUNSEL'S REPORT – Mr. Art Meisel

NJDA had received an invitation to meet with the Department of Environmental Protection. They were given a draft of a proposed regulation that would require dentists to conform to Best Management Practices. This is something that both NJDA has been promoting for the last two or three years and the ADA has been talking about longer. There was one caveat: The Department would add as part of the Best Management Practice a requirement to have amalgam separators in dental offices and facilities. The Department wanted to get a sense of how we felt and we explained that we supported BMP's but opposed the requirement to install amalgam separators. There will be a Task Force convened by DEP and we will have four representatives on that Task Force along with others which include the operators of waste water treatment plants, clean water advocates and others. This will be an informal sit down with no vote but seems to be a mechanism where the various interested groups sit at the table and have a discussion. The DEP will have representatives present and they will listen to everyone before they publish the proposal.

We also received an invitation to meet with Commissioner Campbell of the DEP, the current chair of the Task Force and the senior staff of the DEP. By the end of the meeting, the Commissioner said that we had raised some issues that he really had to think about. Mr. Meisel felt we still have an uphill battle but felt that the door seemed to be open. To assure adequate expertise during the Task Force meeting convened by the DEP, it was decided to reach out to ENVIRON. Environ is the group that did the work for the ADA on an environmental scan. The individual from that group who was very involved was a gentleman by the name of Jay Vandevan. The report that was performed nationally for the ADA has just been published this past May in a peer reviewed journal. Mr. Vandervan has been contacted and has agreed to appear on behalf of the Association at a cost of \$2000. The data seems to show that by use of BMP without amalgam separators, which would include chairside traps and filters immediately before the vacuum pumps, approximately 81% of amalgam would be removed. If amalgam separators are used, an additional 14% would be removed, totaling 95%. If nothing was used, it is estimated that the treatment plant would recover 95%. The main difference is if amalgam is captured in the dental office and disposed of properly, then an estimated eighteen pounds of mercury would not reach the atmosphere in the form of mercury vapor.

### PRESIDENT'S REPORT – Dr. August D. Pellegrini

At the ADA Conference, access to care, licensure with a standard national exam (two remain – ADEX and WREP) and environmental issues were the topics discussed.

NJ Donated Dental Services Annual Report revealed that the DDS program was formed in 1998 and has serviced 6,049 patients, donated care valued at \$9.9 million, with participation of 748 dentists and 130 labs.


