Dr. Goodchild is the Director of Clinical Affairs for Premier Dental Products. He has previously been in private practice in Pennsylvania. He received his DMD from the University of Pennsylvania. He has previously been on faculty at UMDNJ in the departments of Restorative Dentistry, Oral Medicine and Oral Diagnosis (where he also served as Director), and he has been on the faculty of Creighton University School of Dentistry in the departments of Diagnostic Sciences (where he served as Chairman) and Community and Preventative Dentistry. He has many publications in multiple journals, and has presented many lectures and courses.

Achieving profound and effective local anesthesia is essential in clinical practice. It is a limiting step in most procedures; meaning invasive procedures cannot commence until it is successfully achieved.

Despite the frequency that oral health providers (ie, dentists and hygienists) use local anesthetics during clinical practice, misconceptions remain. The goal of this presentation is to discuss several common ‘myths’ surrounding local anesthesia while incorporating literature-supported learning issues.

This course will review and update local anesthetic techniques, equipment, and current research for all providers.

COURSE OBJECTIVES: • Discuss current local anesthetic market share in the US. • Review the basic pharmacology of local anesthetics. • Discuss common ‘myths’ associated with local anesthesia including: Allergy to epinephrine, pH and the impact on injection pain, does needle size make a difference? buffering of local anesthetics, which local anesthetics are safe during pregnancy and lactation, what is the latest on local anesthetic-related paresthesias, review the armamentarium of local anesthetic delivery.

state. Your voluntary contributions to NJDPAC are the only way we strengthen these bonds that help us advance issues important to the profession and halt those policy efforts which do not. Become an NJDPAC member today and help strengthen dentistry's voice in Trenton: <https://www.njda.org/government-affairs/njdpac/join-njdpac>

The NJ Senate narrowly passed legislation, S748, by a vote of 22-9-9 that would add, for the first time, a dental assistant to the NJ State Board of Dentistry. The NJDA opposes this legislation. Advocates for this legislation claim that Dental Assistants have no representation on the Board, while the NJDA's position is that the State Board's principal job is to protect the public's interest and that dental assistants largely lack the knowledge and understanding of complex dental cases to material improve public protection. The NJDA is urging its members to contact their Assemblypersons and asking them to oppose the legislation.

Dental Benefits – Dr. Antoinette Tauk

Dr. Devang Modi is no longer on the Dental Benefits Committee. Dr. Tauk will continue to represent us.

The CODB met on 2/13/19. It was recommended that members purchase the CDT 2019 handbook. There are changes in the language of several codes in addition to new ICD codes that support the medical necessity of several dental procedures. For Medicaid providers that are treating patients in the OR there are many audits being done. Pediatric dentists must have supporting evidence for doing stainless steel crowns and not just a two-surface amalgam or composite, for example, a caries risk assessment. Documentation is very important. The treatment rendered should be fully documented, establish medical necessity and use diagnostic codes. The ADA claim form 2012 has space for four diagnostic codes. Use cross coding to assist in finding appropriate codes. It is inevitable that at some point in the future dentists will be required to use ICD codes which are diagnostic codes to support their diagnosis like our medical colleagues. It would not be a bad idea to start doing this now so that when this does become mandatory one's transition will be easier. If you are in the Medicare Advantage Plan there is a 2.5 year auto renew of form 8550. If you do not want to renew this contract you have a 30-day period from the anniversary date of your contract to opt in or opt out. If you do not do this will be auto renewed for another 2.5 years. The council is working on proposing some new ADA codes. If you are a participating dentist with an insurance carrier, there are procedures for which a patient can be charged an upgraded fee in addition to your negotiated fee. Make certain that you read the carrier's current policy, inform the patient of their choices and have the patient sign a financial informed consent that the carrier provides in their manual. An example of such an upgrade would be Invisalign treatment in lieu of traditional metal braces. The next meeting will be on 5/15/19.

Peer Review - Dr. Steven Susskind

The Board was briefed on two cases: One was a three unit bridge and the second was a partial denture. The message to all members is the importance of documentation and discussing patient expectations to minimize future disagreements.

MCDS Member Dr. Ed Galkin raises money, awareness for Alzheimers Disease.

Dr. Ed Galkin was driving by an airport in early spring 2018 when, he said, he had an epiphany. I said to myself, “Maybe I can do it again.” By “it,” the 82-year-old periodontist and longtime pilot meant flying around the world in a single-engine plane — again. His goal: to raise awareness and money benefiting the Alzheimer’s Association. About two years ago, his older brother, Dr. Sam Galkin, an orthodontist, died from complications from the disease. “It was an awful situation,” Dr. Galkin said. “If the money we raise gets us a little closer to finding a cure for this terrible disease, then it would be worth it.” Dr. Galkin and his co pilot, Marty Balk, set off from New Jersey at 10 a.m. Oct. 26, 2018. Their plane, a Cessna 210 Centurion that Dr. Galkin bought in 1977, would take them eastward across the Atlantic Ocean over the South Pacific and back to the U.S., visiting over a dozen locations, including Cyprus, Bangkok, Fiji and Hawaii. The duo returned at 11 p.m. Nov. 30, after a 16 hour flight from San Jose, California, and a refueling stop in Oklahoma. “No matter where went or who we spoke with, many told us about friends and family who were affected by Alzheimer’s,” Dr. Galkin said. “Until this trip, I didn’t realize how significant it was worldwide.” His fundraising campaign continues today in the hopes of raising more than \$25,000 for the association.


